ROCK101'S A LITTLE BIT METAL...FOR THE YUKON! CONTEST RULES

THE ROCK101'S A LITTLE BIT METAL...FOR THE YUKON! CONTEST (THE "CONTEST") WILL BE CONDUCTED IN THE PROVINCE OF BRITISH COLUMBIA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF BRITISH COLUMBIA OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
 - (a) be a legal resident of the province of British Columbia;
 - (b) live within one hundred kilometers (100km) of the City of Vancouver;
 - (c) be of the age of majority in the province of British Columbia;
 - (d) be able to participate in the Prize (as defined) between December 2024 and April 2025; and
 - (e) be legally able to travel to Whitehorse, Yukon and have any and all necessary documentation that may be required for presentation to Canadian and/or International customs and airport personnel.
- 1.2 The following people are not eligible to enter the Contest:

All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. CONTEST PERIOD. The Contest begins at 8:00 am Pacific Time ("PT") on February 26, 2024 and ends at 4:00 pm PT on March 15, 2024 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER.

3.1 There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.

Listen to the Station, Monday to Friday during the Contest Period (excluding statutory holidays) at approximately: (i) 8:00a.m.; (ii) 12:00 p.m.; and (iii) 4:00p.m. PST for the cue to call (the "Cue to Call"). Upon hearing the Cue to Call, listeners are invited to call 604-280-1011 (the "Contest Line"). The first (1) and second (2) listeners to call through the Contest Line will have a chance to play our Pop goes Metal edition of "Name That Tune". The player who can guess the title of the track first will qualify to enter the prize draw (each a "Qualifier"). There will be a total of forty-five (45) Qualifiers.

- 3.2 Limit of one (1) entry per household during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. - 4.2 The Grand Prize has an approximate value of eight thousand two hundred and ninety-nine Canadian dollars (CDN\$8,299) Actual value of Prize will depend on departure city.
- 4.3 Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.4 The Sponsors and/or the Sponsors' representatives will contact the Winner to coordinate the provision of the Prize within one (1) day once such Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- 5.1 All bookings and/or reservations are subject to availability at time of booking. Winner and their Guest must be available to travel from December 2024 through April 2025. Should Winner and/or Guest be unable to travel on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner.

Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release (described below).

Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive the Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
